This BLACK+DECKER® Magical Vacation Sweepstakes (“Sweepstakes”) is sponsored by Black & Decker (U.S.) Inc., 701 E. Joppa Road, Towson, MD 21286 (“BLACK+DECKER”). The entry period of this Sweepstakes is November 1, 2016 at 12:00:00 AM Eastern Time (“ET”) through January 31, 2017 at 11:59:59 PM ET (“Entry Period”). Entry in this Sweepstakes does not constitute entry into any other contest. Retail Sports Marketing, Inc.’s computer will be the official timekeeper for this Sweepstakes. **By entering this Sweepstakes, each entrant fully and unconditionally accepts and agrees to comply with and abide by these Official Rules and all decisions of BLACK+DECKER which shall be final and legally binding in all respects.** Each entrant understands that they are providing their information to BLACK+DECKER and the information provided in connection with this Sweepstakes will be used in accordance with BLACK+DECKER’s privacy policy (found on www.blackanddecker.com). Should there be conflict between BLACK+DECKER’s privacy policy and these Official Rules, these Official Rules shall govern. Any personally identifiable information collected during an entrant’s entry in this Sweepstakes will be collected by BLACK+DECKER or its designee and used by BLACK+DECKER or its designee for purposes of the proper administration, fulfillment, publicizing and promotion of this Sweepstakes as described in these Official Rules, as stated in BLACK+DECKER’s privacy policy or as otherwise expressly consented to by entrants during any separate opt-in opportunity provided to entrants during entry in this Sweepstakes. If an entrant does not fully agree to the terms of these Official Rules, such entrant should not enter this Sweepstakes. One (1) Grand Prize will awarded and one (1) Winner declared. This Sweepstakes is subject to all federal, state and local laws and regulations. Void in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Walt Disney Parks and Resorts U.S. (“Disney”) is not a sponsor of this Sweepstakes.

1. **ELIGIBILITY:** This Sweepstakes is open only to persons who are legal residents of 1 of 50 states of USA or Washington, D.C., age 18 or older the time of entry in this Sweepstakes, and have an official form of personal identification. Employees and members of the Board of Directors of BLACK+DECKER, Stanley Black & Decker, Inc., Snipp Interactive, Inc. (“Snipp”), Disney, and Retail Sports Marketing, Inc. - (4) Complete the registration form and submit the same to Snipp (BD Rewards Program administrator);
- (5) When submitting BD Rewards request to Snipp, entrant (you) must not opt-out of automatic entry in this Sweepstakes;

- (6) Receive validation via email or text from Snipp confirming entrant's (your) successful submission or providing additional instructions entrant (you) must follow to receive such validation;
- (7) Entrant (you) must receive validation from Snipp of successful submission to receive automatic entry in this Sweepstakes via the BD Rewards Program.

By texting KEYWORD: BDREWARDS to 811811 you consent to receive up to 10 promotional text messages from Snipp on behalf of BD Rewards (pertaining to the BD Rewards Program only) via an automatic telephone dialing system to the number you provided. Limit one (1) receipt with each submission. The approximate retail value of the Grand Prize vacation is \$12,745.05.
